



## Invitation to Bid for the Trucking and Hustling Services 2014 - 2016 PDD1401

DFPC now invites bids for the **Provision of Trucking and Hustling Services**. Interested bidders should have completed within the last two (2) years (2012-2013) from the date of submission and receipt of bids, a contract similar to the Project. Bidders must have a motor pool or garage within Metro Manila. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using the non-discretionary "pass/fail" criterion as specified in the Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act" and is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested Bidders may now obtain further information from DFPC and inspect and/or purchase the Bidding Documents at the address given below from **9:00AM – 5:00PM, Mondays thru Fridays**.



A complete set of Bidding Documents may be purchased by interested Bidders until **03 June 2014** from the address below and upon payment of a nonrefundable fee for the Bidding Documents.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

DFPC will hold a Pre-Bid Conference, however, only those who have purchased the Bidding Documents shall be allowed to participate in the Pre-Bid on **23 May 2014, 10:00AM** at the address given below.

Deadline for submission of Bids shall be on **04 June 2014 at 10:00AM** and Bid opening shall immediately follow at **10:15AM** at the address given below. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

**All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in BDS under ITB Clause 18.**

DFPC reserves the right to waive any formality on the eligibility requirements of this project. Furthermore, DFP reserves the right to reject any and all proposals, to annul the bidding process, or declare a failure of bidding, or not award the contract in any of the situations stated under Section 41 of the Revised IRR of RA 9184, and makes no assurance that a contract shall be entered as a result of this invitation without thereby incurring liability to the affected bidder or bidders.
