## BAC Resolution Recommending Cancellation of Bidding RESOLUTION NO. 202025

WHEREAS, the Duty Free Philippines Corporation (DFPC) Facilities Management Department (FMD) ("end-user") has requested for the **RENOVATION OF DFPC PROVINCIAL STORE OUTLETS – Lot 1 (FMD1915-1)** ("the Project") which was duly approved by the Chief Operating Officer (COO);

WHEREAS, the Bids and Awards Committee (BAC) posted the Invitation to Bid in PHILGEPS, DFPC Website and bulletin boards continuously for seven (7) days from February 4 to 10, 2020;

WHEREAS, on 12 February 2020, Pre-Bid Conference was held and attended by Pampanga Block Builders Inc. (PBBI);

WHEREAS, on 28 February 2020, the scheduled opening of bids, PBBI purchased the bidding documents and submitted its bid proposal. PBBI was declared passed for the Eligibility and Technical Component. However, their bid price exceeded the amount of the Approved Budget for the Contract (ABC);

WHEREAS, on 04 March 2020, PBBI submitted their Request for Reconsideration (RR) within the prescribed period upon which the BAC members have unanimously resolved to deny the said request;

WHEREAS, on 12 March 2020, pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), the BAC declared a Failure of Bidding;


WHEREAS, the Management decided to cancel all projects this year due to precarious financial condition and indefinite resumption of DFPC's normal operation brought about by the COVID-19 pandemic;


WHEREAS, the BAC has concurred the existence of such conditions that make the Project economically, financially or technically impractical and/or unnecessary such as, but not limited to, fortuitous event(s) or changes in law and national government policies;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby resolved as it is hereby **RESOLVED** to recommend to the DFPC COO to declare the following:

- a) Cancellation of the bidding for the above-stated project;
- b) Re-posting of the bidding for the above-stated project with the revised bidding requirements, the new ABC and such other modification the end-user in coordination with the BAC may deem necessary.
