BAC Resolution for the Cancellation of Bidding RESOLUTION NO. 202034

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) ("end-user unit") has requested for the **Supply and Installation of DFPC CCTV System – Lot 2 (OGM1909-2)** (subject procurement) per Memorandum No. SM (2019) 440 which was approved by the Chief Operating Officer (COO);

WHEREAS, the Approved Budget for the Contract (ABC) is Four Million Nine Hundred Fifty Thousand Eight Hundred Five Pesos and 75/100 (PhP4,950,805.75);

WHEREAS, the BAC has undertaken the procurement activities based on the prescribed schedule however due to the fortuitous event brought about COVID-19 pandemic, schedule of activities reached Post-Qualification stage only;

WHEREAS, through Memorandum SM (2020) 153M dated 08 June 2020, the end user unit per management directive, requested the BAC for the cancellation of the bidding due to precarious financial condition and indefinite resumption of DFPC's normal operation brought about by the COVID-19 pandemic;


WHEREAS, without prejudice to Section 35.1 of RA 9184 and its IRR and pursuant to Section 35.6 of the same IRR, the BAC is hereby authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, for any justifiable reason, such as but not limited to:

- a. the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit;
- b. the project is no longer necessary as determined by the end-user unit; and
- c. the source of funds for the project has been withheld or reduced through no fault of the PE;
- d. brought about by the declaration of a State of Calamity, or implementation of community quarantine or similar restrictions.

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend to the DFPC COO to declare the Cancellation of the bidding for the **Supply and Installation of DFPC CCTV System – Lot 2 (OGM1909-2)**.
