



BAC Resolution Recommending Approval of the Contract
RESOLUTION NO. 2015100

WHEREAS, the Duty Free Philippines Corporation (DFPC) – Bids and Awards Committee (BAC) posted the Notice of Negotiated Procurement for the **Christmas Decor 2015 (MKTG1503)** (“subject procurement”) in the PHILGEPS, DFPC Website, and bulletin boards continuously for seven (7) days from 06 - 12 May 2015;

WHEREAS, the DFPC Bids and Awards Committee (BAC), thru its Resolution No. 201539 resolved to recommend to the DFPC Chief Operating Officer that the Alternative Method of Procurement, particularly under Section 53.1 of the Revised Implementing Rules and Regulations (IRR) of the Republic Act No. 9184 (RA 9184), be resorted to in the subject procurement;

WHEREAS, the said recommendation was duly approved by the DFPC Chief Operating Officer on 06 April 2015;

WHEREAS, DFPC sent invitations to three (3) consultants, namely, 4th Wall Production and Design (4th Wall), Casfer Advertising (Casfer), and Natural Art;

WHEREAS, only one (1) consultant, 4th Wall submitted its proposal together with their eligibility documents and was found eligible on 29 May 2015;

WHEREAS, the result of the rating of the Technical Component is as follows:

WHEREAS, the financial proposal of 4th Wall was found to be substantially complying and the result is as follows:

WHEREAS, on 24 August 2015, 4th Wall presented the proposed design to the End User and due to some revisions another presentation was scheduled;

WHEREAS, on 10 September 2015, 4th Wall presented the revised design and was found to be satisfactory;
