



**BAC Resolution Declaring the Single Calculated and Responsive Bidder and Recommending Award of Contract**  
Resolution No. 201658

WHEREAS, Duty Free Philippines Corporation (DFPC) advertised the Invitation to Bid for the **Provision of Healthcare Services (HRMD1601)** in a newspaper of general nationwide circulation and posted the same in the PHILGEPS, DFPC Website, and bulletin boards continuously for seven (7) days from April 29 – May 06, 2016;

WHEREAS, on 05 August 2016, the Bids and Awards Committee (BAC) held the pre-bid conference which was attended by two (2) prospective bidders, United Cocolife Planters Assurance Corp. (Cocolife) and Maxicare Healthcare Corp.(Maxicare);

WHEREAS, on 25 August 2016 - the scheduled opening of bids, above-stated two (2) prospective bidders submitted their respective bid proposals. Maxicare was found to be eligible while Cocolife was declared failed due to non-submission of sufficient number of Certificate of Good Standing for Manila hospitals and non-submission of Certificate of Good Standing for Cavite, Laguna, Rizal, Albay and Aklan and omission of item 8e of the Omnibus Sworn Statement;

WHEREAS, Cocolife submitted its Motion for Reconsideration (MR) on 30 August 2016 but was subsequently denied by BAC;

WHEREAS, its financial proposal was opened and below is the result:
