To:

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **27 April 2021, 10:00AM**. Late bids shall not be accepted.

3. Invitation to Bid, 9<sup>th</sup> Paragraph

From:

Bid opening shall be 20 April 2021 10:15AM at the address given below and/or via Microsoft Teams. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

To:

Bid opening shall be **27 April 2021, 10:15AM** at the address given below and/or via Microsoft Teams. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.



4. Instruction to Bidders (ITB) Clause 14.2

To:
