TO:

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **03 June 2021, 10:00AM**. Late bids shall not be accepted.

2. Invitation to Bid, 8th Paragraph:

FROM:

Bid opening shall be on 20 May 2021, 10:15AM at the given address below and/or via Microsoft Teams. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

TO:

Bid opening shall be on **03 June 2021, 10:15AM** at the given address below and/or via *Microsoft Teams*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

3. Instruction to Bidders (ITB) Clause 14.2:

FROM:

The Bid and bid security shall be valid until 17 September 2021. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

TO:

The Bid and bid security shall be valid until **01 October 2021**. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.
