**TO:**

Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **27 May 2022, 10:00AM**. Late bids shall not be accepted.

3. Invitation to Bid, 8th Paragraph:

**FROM:**

Bid opening shall be on 13 May 2021, 10:15AM at the given address below and/or via Microsoft Teams. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

**TO:**

Bid opening shall be on **27 May 2022, 10:05AM** at the given address below and/or *via Microsoft Teams*. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.



4. Instruction to Bidders (ITB) Clause 14.2:

**FROM:**

The Bid and bid security shall be valid until 10 September 2022. Any Bid not accompanied by an acceptable bid security shall be rejected by the Procuring Entity as non-responsive.

**TO:**
