

Agreement

THIS AGREEMENT made this FEB 01 2018 day of _____ 2017 between **DUTY FREE PHILIPPINES CORPORATION** (hereinafter called "the Entity") of the one part and **PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC.** with address at 3F Hollywood Square Building #33 West Avenue Quezon City (hereinafter called "the Supplier") of the other part:

WHEREAS the Entity invited Bids for the **Supply and Installation of Network Infrastructure for DFPC NAIA T3 - Landside Store (MIS1602)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **Five Million Seven Hundred Ninety Nine Thousand Seven Hundred Twenty One Pesos and 42/100 (5,799,721.42)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) the Bid Form and the Price Schedule submitted by the Bidder;
 - b) the Schedule of Requirements;
 - c) the Technical Specifications;
 - d) the General Conditions of Contract;
 - e) the Special Conditions of Contract;
 - f) the Supplemental/Bid Bulletin; and
 - g) Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


