

CONTRACT AGREEMENT

THIS AGREEMENT made the 21 day of JUN 21 2021 2021 between **DUTY FREE PHILIPPINES CORPORATION (DFPC)** (hereinafter called "the Entity") of the one part and **WORLD CUP SECURITY SERVICES INC. (WCSSI)** with address at Rm 9-B Arquiza Trade Center Building, 1214 M.H. del Pilar St., cor Arquiza St., Ermita, Manila (hereinafter called "the Supplier") of the other part:

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **PROVISION OF SECURITY SERVICES FOR DFPC STORES LOT 1** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Twenty Three Million Six Hundred Thirty Three Thousand Six Hundred Fifty Eight Pesos and 75/100 (Php23,633,658.75)** (hereinafter called "the Contract Price").


NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. **WCSSI's** bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in **WCSSI** bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the **WCSSI's** conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **WCSSI** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **Twenty Three Million Six Hundred Thirty Three Thousand Six hundred Fifty Eight Pesos and 75/100 (Php23,633,658.75)** or such other sums as may be ascertained, **WORLD CUP SECURITY SERVICES INC. (WCSSI)** agrees to the provision of security services for Duty Free Stores/premise located at FiestaMall Store/Forward Warehouse, NAIA T2, NAIA T3 and Luxe Duty Free in accordance with his/her/its Bid.
4. **DFPC** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




