

CONTRACT AGREEMENT**CITY OF MANILA****JUN 21 2021**

THIS AGREEMENT made the _____ day of _____ 20____ between **Duty Free Philippines Corporation** of the Philippines (hereinafter called "the Entity") of the one part and **World Cup Security Services, Inc.** of Rm 9-B Arquiza Trade Center Building, 1214 M.H. del Pilar St., cor Arquiza St., Ermita, Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Provision of Security Services for DFPC Stores Lot 5 – Other Store Outlets (Kalibo, Bacolod and Iloilo)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million One Hundred Forty Nine Thousand Three Hundred Thirty One Pesos and 70/100 (Php2,149,331.70)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. **WCSSI's bid**, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted

 Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **WCSSI agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Two Million One Hundred Forty Nine Thousand Three Hundred Thirty One Pesos and 70/100 (Php2,149,331.70)** or such other sums as may be ascertained, **World Cup Security Services, Inc.** agrees to the provision of security services for Duty Free outlets in Kalibo, Bacolod and Iloilo International Airports in accordance with his/her/its Bid.
4. **Duty Free Philippines Corporation** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
