

Contract Agreement Form

WHEREAS the Entity invited Bids for the **Christmas Décor 2015 (Negotiated Procurement)** and has accepted the Bid by the Supplier for the supply of those goods and services in the sum of **One Million Five Hundred Ninety-Nine Thousand Nine Hundred Ninety-Nine Pesos (PhP1,599,999.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - f. Entity's Notification of Award
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects
4. The Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


