**BAC Resolution Declaring Failure of Bidding**

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) (“end-user”) has requested for the **Provision of Security Services for DFPC Stores (OCOO2021-01)** (“the Project”) consisting of three (3) Lots for a period of one (1) year which was approved by the Chief Operating Officer (COO), details as follows:

WHEREAS, the Project was posted for the second (2<sup>nd</sup>) time in the PHILGEPSS, DFP Website and bulletin board continuously from February 8 to 15, 2021;

WHEREAS, Pre-Bid conference was held on 17 February 2021 and attended to by three (3) bidders: Tough Guard Security and Investigation, Inc., World Cup Security Services, Inc. (World Cup) and Leopard Security & Investigation Agency (Leopard) through a combination of face-to-face and virtual conference *via Microsoft Teams*;

WHEREAS, World Cup and Leopard purchased the bidding documents and submitted their respective bid proposals on 02 March 2021. The result of the preliminary examination of bids is as follows:

WHEREAS, World Cup will advance to post-qualification stage for Lots 1 and 2;


WHEREAS, for Lot 5, no Request for Reconsideration was submitted by World Cup within the prescribed period;
