BAC Resolution Declaring Failure of Bidding

Resolution No. 202104

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) ("end-user") has requested for the **Provision of Security Services for DFPC Stores (OCOO2021-01)** ("the Project") consisting of five (5) Lots for a period of one (1) year which was approved by the Chief Operating Officer (COO);

WHEREAS, by way of Resolution No. 202101, the BAC conducted the procurement activity for the five (5) store locations in accordance with the prescribed timeline;

WHEREAS, as a result, BAC declared Failure of Bidding for Lots 1, 2 & 5 which was approved by COO on 27 January 2021;

WHEREAS, BAC issued another Resolution No. 202103 recommending award to MINSAS for Lot 4 to DFPC COO while the post-qualification conducted by TWG on the bid proposal of Philand for Lot 3 was found to be non-responsive on account of the following:

1. Out of the three (3) submitted base units; only one (1) has a valid license as required under Section VII. Specifications;
2. Submitted Sworn Affidavit makes no direct reference to recruitment and selection processes in relation to Section VII. Specifications-Item D;
3. Submitted Sworn Affidavit of compliance that manpower and logistical requirements will be complied with within fifteen (15) days from receipt of the Notice to Proceed (NTP), as a post-qualification requirement, was unsigned by the authorized representative;
4. Submitted Sworn Affidavit that the security personnel subject for deployment are not related to one another and any of the officers/employees of the PROCURING ENTITY, up to the fourth (4th) civil degree of consanguinity or affinity, as a post-qualification requirement, was unsigned by the authorized representative; and
5. Signed stamp indicating receipt of the GIS by the Securities and Exchange Commission (SEC) was not visible.

WHEREAS, no Request for Reconsideration was submitted by Philand within the prescribed period;

WHEREAS, pursuant to Section 35.1(c) of the 2016 Revised IRR of RA 9184, the Bids and Awards Committee shall declare a failure of bidding when all bids fail to comply with all the bid requirements or fail post-qualification;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby RESOLVED to recommend to the DFPC Chief Operating Officer to declare FAILURE OF BIDDING for the project **Provision of Security Services for DFPC Stores Lot 3 (OCOO2021-01-03)**.







