



Invitation to Apply for Eligibility and to Bid

Supply and Delivery of IT Equipment (Laptop, Computers & Printers)

1. **Duty Free Philippines (DFP)**, a sector of the Philippine Tourism Authority, now invites Bids from eligible Bidders for:

Bids received in excess of the ABC shall be automatically rejected at Bid opening.

2. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the Implementing Rules and Regulations Part A (IRR-A) of Republic Act 9184 (R.A. 9184), otherwise known as the "Government Procurement Reform Act," and is restricted to Filipino citizens/sole proprietorships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to Republic Act 5183 (R.A 5183) and subject to Commonwealth Act 138 (C.A. 138). Only Bids from Bidders who pass the eligibility check will be opened. The bidder with the Lowest Calculated Bid (LCB) shall advance to the post-qualification stage in order to finally determine responsiveness of the bid to technical and financial requirements of the project. The contract shall then be awarded to the Lowest Calculated and Responsive Bidder (LCRB) who was determined as such during the post-qualification procedure.
3. Interested Bidders may now obtain further information from **DFP** and inspect the Bidding Documents at the address given below from **9:00A.M. – 5:00P.M., Mondays thru Fridays**.
4. A complete set of Bidding Documents may now be purchased by interested Bidders from **November 13 to December 01, 2006** from the address given below upon payment of a nonrefundable fee in the amount of **Five Thousand Pesos (PhP5,000.00) regardless of the number of lots to be bid**. The method of payment will be **Cash**. The Bidding Documents shall be received personally by the prospective Bidder or his authorized representative.
5. **DFP** will hold a Pre-Bid Conference open to all interested parties on **November 20, 2006 10:00A.M.** at the address given below.



6. Bids and eligibility requirements must be delivered to the address below on **December 04, 2006 at 2:00P.M.** Late bids shall not be accepted. All Bids must be accompanied by a Bid security in the form of:

8. Bid opening shall be on **December 04, 2006 2:15 P.M.** at the address given below. Bids will be opened in the presence of the Bidders' representatives who choose to attend.
9. **DFP** reserves the right to waive any formality on the eligibility requirements of this project. Furthermore, DFP reserves the right to reject any and all proposals, or declare a failure of bidding, or not award the contract, and makes no assurance that a contract shall be entered as a result of this invitation without thereby incurring liability to the affected bidder or bidders.
