



**BAC Resolution Declaring Failure of Bidding**  
**RESOLUTION NO. 202006**

WHEREAS, Duty Free Philippines Corporation (DFPC) Marketing Department (“end-user”) has requested for the **Marketing Research and Brand Audit for Duty Free Philippines (MKTG1903)** (“the Project”) which was duly approved by the Chief Operating Officer (COO);

WHEREAS, the DFPC BAC through its Resolution No. 201981 recommended to and approved by the DFPC Chief Operating Officer (COO) on 26 November 2019 that an alternative mode of procurement, particularly Negotiated Procurement under Section 53.1 of the 2016 Revised IRR of R.A. 9184, be resorted to in the subject procurement;

WHEREAS, BAC posted the Notice for Negotiated Procurement for the Project in the PHILGEPS, DFPC Website and bulletin board for four (4) days from January 10 to 14, 2020;

WHEREAS, invitation was sent to three (3) Consultants: Market Relevance Corporation, People Dynamics, Inc. and I-Metrics Asia Pacific Corporation on 10 January 2020;

WHEREAS, on 15 January 2020, only I-Metrics submitted its eligibility documents and was declared ineligible due to the following:


1. Eligibility Documents Submission Form (Annex A) was not notarized; and
2. Submission of expired Mayor’s Permit as reflected in “Annex A”-List of Eligibility Documents of PhilGEPS Certificate.

WHEREAS, no Request for Reconsideration (RR) was submitted by I-Metrics within the prescribed period;

WHEREAS, pursuant to Section 35.1(b) of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184 (RA 9184), the BAC shall declare a failure of bidding when all prospective bidders are declared ineligible;


NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to recommend to the DFPC Chief Operating Officer to declare a **FAILURE OF BIDDING** for the project **Marketing Research and Brand Audit for Duty Free Philippines (MKTG1903) (Negotiated Procurement)**.


