## BAC Resolution Recommending Cancellation of Bidding RESOLUTION NO. 202020

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) ("end-user") has requested for the **Provision of Security Services for DFPC Manila (OCOO2020-02)** ("the Project) for a period of one (1) year as follows:

Lot 2	Fiestamall Perimeter, EHA Building, Integrated Warehouse and NAIA Terminal 1	Thirty Four Million NineHundred Forty Four Thousand One Hundred Sixty Five Pesos and 60/100 (PhP34,944,165.60)

WHEREAS, the Bids and Awards Committee (BAC) posted the Invitation to Bid at the PHILGEPSS, DFP Website and bulletin boards continuously for seven (7) days from February 20 – 27, 2020;

WHEREAS, on 27 February 2020, Pre-Bid conference was held and attended to by three (3) prospective bidders; World Cup Security Services, Inc. (WCSSI), Leopard Security & Investigation Agency, Inc. (LSIA) and Vigilant Investigation & Security Agency, Inc. (VISAI);

WHEREAS, the following prospective bidders purchased the bidding documents and expressed their intention to bid on the following Lots:

WHEREAS, the deadline for submission/opening of bids is scheduled on March 18, 2020 but was rescheduled to April 21, 2020, May 05, 2020 and May 19, 2020 per Bid Bulletin Nos. SSM-001, SSM-002 and SSM-003, respectively, due to Enhanced Community Quarantine (ECQ) mandated by the government;

WHEREAS, the Security Department through Memorandum SM(2020)-142M dated 13 May 2020 with the approval of the Head of the Procuring Entity, has requested the BAC for the cancellation of the bidding in consideration of the "New Normal" which will eventually be adopted by DFPC as a result of the COVID-19 pandemic;

WHEREAS, the BAC has concurred the existence of such conditions that make the Project economically, financially or technically impractical and/or unnecessary due to changes in law and national government policies "brought about by the COVID-19 pandemic";




