



**BAC Resolution Declaring Lowest Calculated and Responsive Bid
and Recommending Award of the Contract**

Resolution No. 202107

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) (“end-user”) has requested for the **Provision of Security Services for DFPC Stores (OCOO2021-01)** (“the Project”) consisting of five (5) Lots for a period of one (1) year which was approved by the Chief Operating Officer (COO);

WHEREAS, by way of Resolution No. 202105, the BAC conducted the procurement activity for the second time for Lots 1, 2 & 5 in accordance with the prescribed timeline;

WHEREAS, based on the same Resolution No. 202105, BAC declared Failure of Bidding for the second (2nd) time for Lot 5 which was approved by COO on 10 March 2021;

WHEREAS, for Lots 1 & 2, both participating bidders: Leopard for Lot 1 and World Cup for Lots 1 & 2, passed the preliminary examination of bids. Their respective financial components were opened and found to be substantially complying. The result is as follows:




