



**BAC Resolution Declaring Single Calculated and Responsive Bid
and Recommending Award of the Contract**

Resolution No. 202111

WHEREAS, the Duty Free Philippines Corporation (DFPC) Security Department (SD) (“end-user”) has requested for the **Provision of Security Services for DFPC Stores (OCOO2021-01)** (“the Project”) consisting of five (5) Lots for a period of one (1) year which was approved by the Chief Operating Officer (COO);

WHEREAS, the Project, particularly Lot 3 – Clark, was posted for the second (2nd) time in the PhilGEPS, DFP Website and bulletin board continuously from March 16 to 23, 2021;

WHEREAS, Pre-Bid conference was held on 24 March 2021 and attended to by two (2) bidders: World Cup Security Services, Inc. (World Cup) and Philand Security Agency, Inc. (Philand) through combination of face-to-face and virtual conference via *Microsoft Teams*;

WHEREAS, World Cup and Philand purchased the bidding documents and submitted their respective bid proposals on 13 April 2021.

WHEREAS, World Cup passed the preliminary examination and the result of financial proposal is as follows:

WHEREAS, Philand was declared failed on account of the following:

1. Failure to attach valid and current Agreement/Contract with a duly accredited security training school; and
2. Disposition of Manpower and Firearms (September to November 2020) was not duly received by PNP-SOSIA.

WHEREAS, on 16 April 2021, Philand submitted its Request for Reconsideration but was subsequently denied by the BAC;

WHEREAS, after careful examination, verification, validation and ascertainment of all the eligibility/technical and financial requirements submitted by World Cup, its bid proposal was found to be responsive to all the requirements therefore post-qualified;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby resolve as it is hereby **RESOLVED** to declare World Cup Security Services, Inc. as the bidder with the Single Calculated and Responsive Bid (SCRB) and recommend for approval by the Chief Operating Officer of DFPC the Award of Contract for the **Provision of Security Services for DFPC Stores Lot 3-Clark (OCOO2021-01-03)** to **World Cup Security Services, Inc.**


