



**BAC Resolution Recommending Approval of the Contract
 RESOLUTION NO. 202013**

WHEREAS, the Duty Free Philippines Corporation (DFPC) – Bids and Awards Committee (BAC) received Memorandum HRMD-MDD-Training (2020) IOM-32 dated 05 March 2020 from the Human Resource Management Division (“end-user”) based on Memorandum HRMD-MDD-Training (2020) IOM - 28 dated 14 February 2020 approved by the Chief Operating Officer (COO), requesting for the “Lease of Venue for the conduct of Strategic Planning for the DFPC Management” (HRMD2020-03) (subject procurement);

WHEREAS, the Approved Budget for the Contract (ABC) for the subject procurement is Five Hundred Thousand Pesos (PhP500,000.00);

WHEREAS, the project is in accordance with the approved Annual Procurement Plan (APP);


WHEREAS, the subject procurement necessitates a location which provides uninterrupted and conducive environment for the conduct of strategic planning to cascade the outputs to the DFPC Managers from the initial session with the DFPC Board. The end-user considered three (3) locations in Batangas: Vivere Azure (Vivere), Anilao Awari Beach Resort (Anilao) and Camp Netanya Resorts & Spa (Camp Netanya) taking into account the availability of facility and prevailing rental rates;


WHEREAS, it was determined that no government-owned venue is located within the vicinity of the selected location thus, recommending the lease of privately owned venue;

WHEREAS, Request for Quotation (RFQ) was sent to three (3) abovementioned venues and each entity submitted its respective quotations and were rated in accordance with the technical specifications prepared pursuant to Appendix B of Annex “H”-Consolidated Guidelines for the Alternative Methods of Procurement of 2016 Revised IRR of RA 9184. Vivere is not equipped with a function room while Anilao exceeded the ABC. Camp Netanya submitted the lowest quotation and has been found to be compliant with all of DFPC’s requirements among others, prudence and economy in government service, suitability of the area in relation to the mandate of the office;

NOW, THEREFORE, We, the members of the Bids and Awards Committee hereby resolve as it is hereby RESOLVED to declare the quotation of **Camp Netanya Resort & Spa** as the Lowest Calculated and Responsive Quotation (LCRQ) pursuant to Section 53.10 of the 2016 Revised IRR of RA 9184 and recommend for approval by the Chief Operating Officer of DFPC the Award of Contract for the “Lease of Venue for the conduct of Strategic Planning for the DFPC Management” (HRMD2020-03)” at the contract price of **Four Hundred Eighty Nine Thousand Six Hundred Fifty Pesos (PhP489,650.00)**.




