



**BAC Resolution Recommending Single Calculated and Responsive Quotation and Recommending Award of Contract
 RESOLUTION NO. 202047**

WHEREAS, the Duty Free Philippines Corporation (DFPC) Administrative Department (“the end-user unit”) has requested for the rental services of Photocopying Machines (AD2020-01) (“the Project”) through Purchase Request No. 9522 dated 04 March 2020 which was approved by the DFPC Chief Operating Officer (COO);

WHEREAS, the Project is in accordance with the approved Annual Procurement Plan (APP);

WHEREAS, the Approved Budget for the Contract (ABC) is Seven Hundred Seventy Three Thousand Five Hundred Sixty Seven Pesos and 02/100 (PhP773,567.02);

WHEREAS, the Project is intended for corporate use for a period of one (1) year;

WHEREAS, Request for Submission of Quotation (RFQ) was posted at the PhilGEPS, DFPC Website and Bulletin Board for three (3) days from November 09-12, 2020. Said RFQ was sent to three (3) Suppliers/Providers of known qualifications namely: U-Bix Corporation (U-Bix), Ecopy Corporation (Ecopy) and Philcopy Corporation (PhilCopy);

WHEREAS, out of the three (3) above-named Suppliers, only U-Bix submitted its quotation;

WHEREAS, Photopro Trading & General Merchandise Co. (Photopro) who became aware of the project through the posting in PhilGEPS, submitted also a quotation;

WHEREAS, the quotation submitted by Photopro was not considered since they failed to include the Certification from the principal that said Supplier is an exclusive distributor of the photocopying machine as required under Technical Specifications;

WHEREAS, based on the Abstract of Quotation, U-Bix submitted its quotation as hereunder specified:

WHEREAS, per evaluation conducted by the end-user, the lone price quotation has been found complying with the terms and conditions of the contract;

WHEREAS, after careful verification, validation and ascertainment of all statements and documents submitted by U-Bix, its quotation was found to be responsive to all the requirements and conditions as required under the law.
